The Bad Seed

Since her divorce and return to Uzbekistan in 2001 Gulnara Karimova, the elder daughter of President Islam Karimov, has received at least USS1 billion worth of shares and payments from foreign telecom-related companies paying for her support and influence. The number of companies and amount of money paid to her is far higher than previously has been revealed. The Organized Crime and Corruption Reporting Project (OCCRP) has obtained records showing how the president's daughter wielded her familial power, applied pressure to major companies, and obtained mass wealth.
