




The EDF and precursor programmes were largely based on the advisory report of the 2016 Group of Personalities

modus operandi & strategies

Two major narratives to support their influence:

- Growth & jobs, competitiveness
 Arms exports > global competitiveness > technological race with US/China > European prosperity & "way of life"
- Security provider
 Arms exports > affordable military equipment > security > sustainability > democracy
- ✓ they no longer only want to exert influence behind closed doors, but also in public debate
- ✓ trying (and succeeding) to improve their image as:
 - sustainable guarantor of security
 - a friendly sports sponsor next door
 - saviour of a faltering economy
- ✓ the arms industry is gaining more and more self-confidence. Its representatives are increasingly appearing as experts in the media





◆ Lack of accountability and transparency while preparing the wars of the future:

- x exemption clause & implementing acts side-lining the EP
- x poor ethical checks & undisclosed list of experts
- * limited available information on technologies being developed (AI, unmanned & autonomous weapons, laser tech, hypersonic weapons...)

Arms exports & the global arms race:

- * Facilitating exports of jointly produced / acquired weaponry
- * Western components in Russian weaponry... The French case, others?
- Value of the New Arsenal for Europe... and beyond?

◆ Rearmament and the climate emergency:

- * The military carbon footprint & the risks of framing climate change as a security threat
- *x* Is there such a thing as green weapons?
- X Diverting sustainable finance (EIB & co), skills & raw material




